#### 766 APPLICATION FOR THE GRANT OF A HACKNEY CARRIAGE LICENCE FOR A FORD FOCUS

The Licensing Officer presented a report asking Members to re-consider an application by a hackney carriage driver to grant a hackney carriage licence for a Ford Focus, a vehicle not fully accessible to the disabled.

The Licensing Officer outlined details of the case and brought to Members attention the legal advice sought after the application was refused in February 2006.

Members asked various questions in relation to issues raised and the Licensing Officer responded to them.

The Members considered the application an resolved to grant a licence for a vehicle which did not have wheelchair access.

## **RESOLVED:**

That the application for a Hackney Carriage Licence be granted in respect of the vehicle, with the vehicle being exempted from the requirement for it to be fully accessible to the disabled, on the basis that hardship grounds had been satisfied.
