Introduction:

Selby District Council has a full programme of Kitchen Replacement work planned for the next 3 years. The estimated cost of the programme is £600,000.00 Budget has been allocated accordingly.

There are approximately 70 properties (value £130,721) identified in need of immediate repairs in 14/15, and a further replacement programme of 140 nr over years 2 and 3, these immediate replacements have been identified on the phase 1 schedule of works supplied to En Procure that has served as the tender information. This contract gives an option to extend on a call off basis for up to 3 years.

Route to Market:

The value of the works falls short of any EU tender thresholds – as this is considered to be a programme of works (not provision of services). However, as the value is over £50k, our CPR's require for us to either run a formal tender process or appoint a supplier via the use of a suitable framework agreement. Our in-depth involvement and understanding of the Efficiency North Programme gave us a very sensible and fully compliant access to an appropriate framework, and this is the route we chose to take to market in agreement with our Procurement Advisor (Dale Casson).
