<b>Reason for decision:</b>	<p>As to do so is in accordance with the legislation and Council Constitution.</p> <p>Scheme of Delegation Section 3.9 to provide grants and other financial assistance. Part 1 of the Localism Act 2011 applies a general power of competence to local authorities in England.</p>

	Section 1 (1) of the Act provides that “a local authority has power to do anything that individuals generally may do”. This includes the power to make grants where to do would be in the interests of the Council, the District and the inhabitants.
