The church would be able to be used for more community events by being better equipped for groups and organisations who may want to use it.</p> <p><b>Agreed outcomes:</b> To purchase 60 high quality, lightweight chairs, 3 - 5 dollies to move the chairs, (12 of these chairs will have arms to help those who find sitting down and getting up difficult) and 8 GoPak tables.</p>	<p>Environment and Streetscape</p> <p>Economy, Retail and Tourism</p> <p>Leisure, Culture and Education</p>	<p><b>£2,000</b></p> <p><i>(see reason for amended amount in the adjacent decision column)</i></p>	<p><b>Decision:</b> APPROVE FUNDING OF <b>£2,000</b></p> <p><b>Reason for decision:</b> Due to the budget setting process, the Tadcaster &amp; Villages CEF budget for 2019-20 had not been before Council, and was therefore not confirmed. As such the Board were unable to commit funding for the next financial year. The Board and applicant were asked to consider two options; to award £2,000 only, or delay consideration of the application and re-submit in the next financial year 2019-20. <b>It was agreed by the applicant and the Board that the church would accept an award of £2,000 part funding in 2018-19.</b></p>
