What is a CEF?

- CEFs are public meetings at which people can raise concerns or make comments about the local area and services.
- CEFs have two elements: an open Community Forum where all residents of the CEF area can attend, and a Partnership Board meeting which is also open to the public but contributions can only be made at the Chair's discretion.
- The Community Forum meetings give residents a chance to speak directly to the people who deliver local services, for example policing, street cleaning and road safety.
- The Partnership Board meeting is where funding applications are discussed, and the direction of the CEF is discussed. The Board is made up of district councillors, parish councillors and co-opted members of the community.

Community Engagement Forums

There are 5 CEF areas across the District; the CEFs are SDC's main community engagement vehicle.

CEF Aims

- Influence how services are planned and delivered in their area;
- Contribute to identifying and implementing solutions to address local concerns;
- Contribute to setting the priorities of those authorities, agencies and organisations which deliver public services in the area.



CEF Meeting Model

CEF Chairs Meeting

- Led by Portfolio Member – Communities and Economic Development
- 5 Chairs meet to discuss priorities, progress, synergies and key issues

CEF Partnership Board

- Annually agreed positions for Chair and Vice Chair
- Consist of SDC, NYCC, town/parish and co-opted community members
- All voting members review CDP, consider funding decisions for officer approval

CEF Funding Sub Committee

- Small, nominated group from Partnership Board review funding applications against the CDPs and make recommendations of support

CEF Public Engagement Forum

- Open public forum with market place liaison
- Representatives from public services can attend and update on local issues (Police, Planning, Fire etc.)
- Regular speakers on key, local issues
