Title of Decision:	Expansion of Discretionary Discount Scheme Relief for Businesses Affected by Covid-19

Details of decision:	The government have recently announced urgent budget measures regarding business rates to provide support for businesses following the Covid-19 outbreak. The Council is expected to implement these measures as quickly as possible to provide immediate help to businesses, they are being asked to do this using their discretionary powers under Section 47 of the Local Government Finance Act 1988 to grant these reliefs. Local authorities should adopt a local scheme to determine each individual case, having regard to the further guidance provided to

	<ul> <li>apply this relief under Section 47. Central Government will fully reimburse local authorities for these using a grant under Section 31 of the Local Government Act 2003.</li> <li>In the week commencing 23 March 2020 further properties were added to the eligible list by Central Government. On the 26 March 2020 the Business Rate Information Letter (BRIL 5_2020) was issued and confirmed the extension of relief to some properties previously excluded as they have now been ordered to close.</li> <li>i. This decision is urgent, due to putting in place arrangements for Covid-19, the Leader agrees that:</li> <li>a. the Council will implement with immediate effect, 30 March 2020, the Government's financial rescue package for the additional list of businesses to support and protect businesses affected by Covid-19; and</li> <li>b. That the new discounts apply from the 1 April 2020.</li> <li>ii. That delegated authority is given to the Head of Operational Services to administer the approved Scheme.</li> </ul>
Reason for decision:	To administer the government's business rate relief scheme to assist businesses affected by Covid-19.
Alternative options considered and rejected:	N/A
Member Interests: (Name of any Member who has declared a conflict of interest in relation to the decision and details of any dispensation granted by the Head of Paid Service if appropriate)	None.
Legal, Financial or other implications:	The government will fully reimburse Council's for the cost of reliefs provided under the new measures by Section 31 grants. The estimated number of businesses who will benefit from the relief is 1,100 who in total will receive over £5 million. A further 18 businesses will benefit for the reliefs who will receive over £56,000.

	<ul> <li>Fully documented decisions by officers of the reliefs applied to accounts will be made to ensure all external audit requirements are fulfilled and to ensure maximum return of costs on NNDR returns to Central Government</li> <li>The decision is within the Budget and Policy Framework and is not a Key Decision, therefore there is no requirement to consult the Chairs of the Policy Review and Scrutiny Committees on this occasion.</li> <li>As the decision is made under urgency powers it is not subject to call-in. The Chief Executive confirms that the decision proposed is reasonable in all the circumstances and is to be treated as urgent.</li> </ul>
