	<p>The Chief Executive noted that the application was for the construction of 1 No. dwelling on land to the rear of Jubilee Cottage.</p> <p>The Chief Executive was aware that additional representations had been received from the applicant and their agent, requesting that consideration of the application be deferred.</p> <p>Officers explained that an extension to the timescale for determination of the application until August 2020 could be offered to the applicant and their agent.</p> <p>The Chief Executive agreed with the view of Officers that if the timescale extension that was to be offered was not accepted by the applicant and their agent, the application should be brought back to the CEO Urgent Decision Session scheduled for 24 June 2020 for determination.</p> <p>As a result, the Chief Executive resolved that consideration of the application should be deferred.</p>
